I personally believe this is the most important work members can do for RAL next year.

December 2014 Member Art Show December 7 – January 2, 2015

Eligibility and rules: Each member in good standing may enter two works. The maximum length of any framed side is 60 inches. Only **original** works securely framed with hanging wire

are acceptable. The entries must have been completed within the last two years and may not have been exhibited previously in a RAL Member Show. No photographs, no reproductions, no giclées and no wet canvases are allowed. A work having multiple framed parts must meet the two works per member criteria. Entries not meeting the show conditions will not be accepted. RAL retains the right to determine suitability of work for entry in this show. Artist's signature on the Show Agreement also constitutes a commitment to donate 20% of the sale price to the City of Rockville for works sold during the show.

**Reception:** Sunday, December 7, from 1:30-3:30 PM. Presentation of awards at 2 PM. Light refreshments to follow.

Any work left after Wednesday noon will not be insured. There is no storage available. Sales: The Glenview Mansion staff will manage art sales. 

## Critique by Penny Kritt

**T** You have a great idea for a painting or drawing. Whether it's a landscape, objects in a still life, a portrait or even an abstract, you'll have shapes that are dominant. So what do you do with the rest of the composition? *Backgrounds need to be considered before you start painting.* Because the background should be "less" than the rest of the painting, you'll need to know less than *what*!

One option is to make the center of interest a bright color then choose a more muted, neutral color for a background as in *Figure 1* below. If the

background is a very bright color, the muted center of interest gets lost as in *Figure 2*.





Of course, there's no rule that says you have to have a background! In Figure 3 below, it was eliminated completely, and that makes the statement stronger. Now that muted, dusty pink takes on more importance and the line work becomes more prominent.



In the examples above, the background is the same throughout the composition. That uniformity works when you have a very strong center of interest. Or it just might be boring.

Now, let's look at a more complicated background and talk about its relative merits.

Although this is a painting about a figure, the background was required to explain the luxury in which a geisha lives. The ornate wooden chair and the patterned wall design stand in contrast to the simple sheen that glows on her shoulder as it peeks out of her kimono. Note how the chocolate brown vertical shape silhouettes the front of her hair. Conversely, the back of her hair is lost against the black shape in the upper left. This was done to provide a variety of edge techniques. Her richly patterned gown is contrasted against the soft glow of her skin as it disappears into her garment. The whole composition alternates between obvious opulence and hidden promise of other delights.



Date Night

In *Date Night*, we need a complicated background to set the mood for the figures. The baby is finally asleep and everyone else, including the cat, is worn out from the hours she cried. There was supposed to be some romance tonight, but an evening on the town become a soft song on the radio in the living room as the tired parents try to hold each other up long enough for one dance.

Date Night (modified) shows what happens when your center of interest is too similar to the background. In the original, her red shirt and hair clip draw the viewer to the figures. When the color is changed to one similar to the background, both figures seem to disappear! Now all we see is the baby. That's because a red shapes, or any color that's mostly red, becomes the dominant feature of a painting.

From a composition standpoint, this is a busy painting full of shapes. The composition has a stronger center of interest when you make one large abstract shape of the baby and her parents (*Figure 4* above). The staircase is a large triangle that leads you down from the upper right corner and its dark gives prominence to the blond parents. Likewise, the shadows shapes cast by the lamp make the viewer move around the entire painting and back again.

By treating all three figures as one combined, complex shape, that reduces the need for more background. For example, if the couple were doing a country western line dance, the figures would be spread far apart and more background would be required to fill in the space between them. That, in turn, adds even more shapes to the composition and can dilute its power.

Sometimes the background has to convey a lot of information that defines the setting, the time of day, the weather, etc. In *Blue Ridge Barn* above, all the trees are run together in a single shape with just some points at the tops to indicate that they are pine trees. The same is true for the stone walls. Each shape has just enough variation so the viewer can tell what it is. If each tree or stone in the wall was well defined, the composition would just be too busy and confusing. Even though the barn has very little definition, it has enough to make it stand out among the other shapes.

They follow in the footsteps of "Edo" era Japanese Woodblock Print Masters, as well as the Western Impressionists and Post Impressionists who adopted and adapted Zen aesthetics and concepts of design. They explore their own creative, individual styles for expressing their personal artistic visions, using modern concepts of design as well as those from the past.

Their artworks run the gamut from representational to abstract, using both vibrant and subtle palettes.

They use handmade, commercial, origami and Lakota papers from around the world. Many works include images from contemporary magazines, photographs and "treasures" from adventures and life they have shared with people and cultures from other continents of the globe.

#### GLENVIEW MANSION CONFERENCE ROOM SHOWS

You can show your artwork in Glenview Mansion for one month if you have received a 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> or honorable mention award in an RAL juried show. Starting in 2013, artists may have both rooms to exhibit in if a second artist doesn't sign up for the same month within two months of the show's start date; otherwise they will have one room. The receptions at Glenview mansion are 1:30-3:30 pm, on the Sunday after hanging! Preferred drop-off and pick-up times for Glenview Shows are from 9 am to 12 noon. Note: please contact the mansion management ahead of time if you wish to modify the drop-off or pick-up times.

For artwork delivery at the Glenview Mansion, please be prepared to unwrap your work and take the wrappings with you - there is no room to store packing materials at the Mansion. Please bring pliers (needle nose are easy to work with). There is no one to help move artwork from your vehicle to the conference rooms, however, you may use the hand truck that is at the Mansion. You are responsible for hanging your own artwork with help from the Mansion staff. If you have not made labels for your work, please fill out the RAL cards that will be available when you bring your work to the conference room. If you print your own, they should be on card stock. Please do not use the sticky Avery labels, unless you adhere them to foam core or card stock.

If you are unavailable on the appropriate date for pickup, please arrange with someone to pickup for you. There is no room to store your artwork at the Mansion after it comes down.

Please note that in 2014, drop off/pickup switches from Wednesdays to Mondays (unless Monday is a holiday).
